- 10. Resolution 5. This resolution, which is an ordinary resolution, is to renew the directors' annual authority to allot shares in the Company. The directors may only allot shares or grant rights to subscribe for, or convert any security into, shares if authorised to do so by shareholders. Accordingly, this resolution will be proposed as an ordinary resolution to grant new authorities to allot shares and grant rights to subscribe for, or convert any security into, shares (a) up to an aggregate nominal amount of US\$31,568,395, and (b) in connection with a rights issue up to an aggregate nominal amount (reduced by allotments under part (a) of the resolution) of US\$63,136,791.

These amounts represent approximately 33.3 per cent. and approximately 66.6 per cent respectively of the total issued ordinary share capital of the Company as at 21 May 2014, the latest practicable date prior to publication of this document.
